Wedding Venue Options

Wedding Ceremony at Chapel only: R 6500.00

Wedding Ceremony when booking reception as well: R 2000.00

Wedding Ceremony Beach : R 15800.00 (Tide and Weather Bound)

We require you to make an appointment to view the facilities on offer and look forward to being of service to you in anticipation of your event.

Breakages deposit: R 2500.00 completely refundable should none occur, in the event of a wedding exceeding the running later than the scheduled booking an hourly rate will be applicable of R 1000.00 per hour, should the guest book both venue's this fee will only be accountable once.

Our refunds are done weekly on Thursday the following week of the wedding, we require you send a written email disclosing the banking details that should be used for refund by no later than Monday, allowing you as well as Imvubu Lodge time to reconcile any necessary breakages and additional expenses, should this requirement not be met on time the refund will carry over to the following week.

WEDDING CEREMONY PACKAGE

Terms of sale:

The garden is booked for two hours after the scheduled time of the wedding only.

All final arrangement is to be discussed two weeks prior to the wedding date, no further changes will be allowed thereafter.

All décor items are outsourced by the guest, this information should be shared with Imvubu Lodge for arrangements of the setup, any equipment not supplied by Imvubu Lodge will not be included in during our set up. Music volume will be discretionary to manager on duty, this should be kept at a respectable volume for all onsite parties.

We require a guest list including full names and Surnames of all the guests attending the wedding no less than two weeks prior to the scheduled wedding date, failure to comply will result in counting of guests until the number booked for is reached.

Along with the above you will be invoiced for 1 security guard, this arrangement will be to conduct a search on each vehicle entering any prohibited items such as Food and beverage items, also kindly please take note we do not allow you to bring any alcohol onto to the property, in the event that alcohol is found it will be kept by our security team safely until the wedding departure, the guards will be an expense to the guest at R150.00 each for the duration of two hours, thereafter the fee will become hourly at R75.00 ph.

In the case of bad weather, Imvubu Lodge will take no responsibility, you the guest will have to make provision for such events.

Anyone that fails to comply to the above will be asked to leave the property.

The final number of guests may not increase on the day of the wedding this total should be confirmed 2 weeks prior to the wedding date along will full payment of the account, failure to do so will result into event being cancelled, with relevant cancellation policies as per the quote.

Terms of event:

All décor items are outsourced by the guest, this information should be shared with Imvubu Lodge for arrangements of the set up, we require your set up be complete on the day prior to the wedding date no later than 19:00, the set up thereof will remain the responsibility of the supplier, alternatively the guest, Imvubu Lodge will take no responsibility in this regard or strike of this equipment that should be completed the following day of the wedding no later than 12:00 this includes only the indoor equipment; all outdoor décor should be removed the same day of the wedding.

The coordination will include:

The above-mentioned included equipment as per the guest's requirements, any relation to the meals supplied by Imvubu Lodge, the beverage requirements and time slots, we will also coordinate the facilities offered by Imvubu Lodge according the wedding program.

We require:

You our guest should submit the final:
